Contest to Replace Kelly Mitchell (Outreach Vice-Chair): "Likely Norton" On Second Ballot

ROCKFORD, Michigan – As Kelly Mitchell departs her position as the Outreach Vice-Chair of the Michigan Republican Party, for a position within the Trump Administration Energy Department, the contest to fill her vacancy is likely to be won by a military veteran from rural northern Kent County, according to a survey conducted by iCaucus Michigan.

According to Kevin Heine, political strategy advisor for iCaucus Michigan, the three-way race between Kenneth Lloyd (a grassroots activist from Bloomfield Hills), Thomas Norton (a business owner from Sand Lake), and Benjamin Soltis (a party operative from Jackson) has a 3-in-5 chance of going to a second ballot, which will likely be won by Norton. Alternately, according to Heine, there is a 2-in-5 chance that Norton wins outright on the first ballot. "The only path that either Lloyd or Soltis have to winning this contest," Heine said, "is a head-to-head matchup on the second ballot, without Norton, which would be too close to call." However, the chance of that particular second-ballot matchup is less than one percent, according to the ballot analysis.

Complicating the survey analysis, according to Heine, was the unusually high percentage of respondents who were undecided on the first ballot. "In the survey, we quoted the duties and responsibilities of the Outreach Vice-Chair, according to the state party bylaws, and asked respondents to indicate how much that job description factored into their decision. There is a strong correlation between the high number of delegates who take the job description seriously, and the high number of delegates who responded as undecided on the first ballot, which indicates to us that many of these delegates are performing some due diligence research before actually making a decision."

Respondents provided Governor Rick Snyder with a 67% approval rating against 21% disapproval, in contrast with a nearly 80% approval rating provided to departing party chair Ronna McDaniel a week previously against a disapproval rating in middle single digits. The scale average for Snyder (either 6.16 or 6.23 on a 9-point scale, depending upon whether or not the results were filtered), was more than a point below the scale average provided to McDaniel, indicating that not only is there less support for the lame-duck governor, but that the support is weaker as well.

Respondents were also asked to offer an opinion the eight people who are currently being considered for the 2018 republican gubernatorial nomination. (Attorney General Bill Schuette currently leads the pack, with a clear plurality of roughly 26%.) Finally, respondents were asked to weigh in on a potential change to the state party bylaws, with roughly 64% being undecided, while those who did have an opinion broke roughly 2-to-1 in favor of the resolution.

The survey was sent out via e-mail link to a master list consisting of voting and alternate delegates to the April 2016 and/or August 2016 state conventions (4,100+ party operatives and activists), and was conducted January 23rd thru 27th. An overwhelming majority of the 507 respondents self-identified as either "conservative republican" or "insurgency republican" (a loose confederacy of Reform Party refugees, tea party movement leftovers, and the "deplorable vulgarians" attracted to President Trump's populism, all who share the commonality of being political outsiders).

- There is a 40% chance that Tom Norton will win this contest outright on the first ballot.
- Assuming that Norton doesn't win outright on the first ballot (60% probability), it's effectively a statistical given (> 99% probability) that he will be on the second ballot.
- The most likely second-ballot scenario is Norton vs. Soltis (89% probability), but there is a credible chance (11% probability) that a second-ballot scenario might be Lloyd vs. Norton.
- In the probable event that a second-ballot scenario includes Norton, then the most probable result is "likely Norton," regardless of opponent.
- In the unlikely event that a second-ballot scenario is Lloyd vs. Soltis, then such a second-ballot scenario is too close to call (advantage Soltis).
